

## **COUNCIL ON STAFF AFFAIRS**

## Minutes of Tuesday, September 20, 2011

## A. Call to order

Chair Yvonne LeRoy-Landers called the meeting to order at 9:03 AM in the UC Cypress Room.

#### C. SPECIAL ORDER OF THE DAY

1. Interim President's Opening Remarks

Dr. Levy reported that he had a good press conference with the Chancellor and Governor. In February the President's Lecture Series will begin again. The 900 bed Brookwood Hall project is not going forward. Plans for the Health Professions building are going forward. Enrollment looks strong, up about 2%. The cut in state funding will be managed without furloughs at this point. VSU's Phi Kappa Phi received a meritorious designation. VSU has been designated a military-friendly institution. Dr. Levy also briefly discussed broadening the recruitment program. He also announced the administration is looking into a wellness program to help with increasing health care costs. Details to follow.

2. Parliamentarian Appointment

Yvonne thanked Lisa Snipes for her work as parliamentarian as she stepped down from that position. A motion was made and seconded to accept Brian Haugabrook's appointment to the position of Parliamentarian. The vote passed unanimously in favor of the motion. Congratulations and thank you, Brian.

3. The Happening

Yvonne thanked the volunteers who helped out at The Happening.

4. The Hartford & the next phase of "I Caught You Caring"

Becky Murphy talked about Ability Assist available through the Hartford. Campus Wellness is working to get the word out about the many wellness and benefits pieces that people have not been aware of. Two events are planned by Campus Wellness with COSA as a cosponsor. One is to help employees recognize and find resources to deal with stress. The second is for supervisors to help them recognize stress in their staff and direct them to resources that can help. Open enrollment is October 24. The Wellness Fair is scheduled for November 3. Becky presented flyers announcing the two events and asked for COSA's input. A motion was made and seconded to accept the flyers as written with corrections. The vote was unanimous in favor of the motion. Becky continued with a discussion about the "I Caught You Caring" program. Do we want to give it a facelift or move to something new? Those present shared ideas on the best ways to show appreciation and recognition to employees. Becky reviewed old program which was more formal and focused on cards, online. Ideas for doing a facelift to the program: would be more informal, small acknowledgements more often (small tokens and display in the department); each

department would come up with their own ways to recognize employees; tie it into Employee of the Semester; colleagues can recognize each other. COSA voted to facelift the old program and to help with the initiative.
