**COURSE DESCRIPTION**

An introduction to contemporary topics in management of knowledge creation and use. Students will learn the principles and practices of knowledge creation. Discussion topics include indexing process, image indexing, faceted classification for indexing, thesaurus construction, taxonomies, and ontologies. The course includes evaluation of software aids and overview of professional opportunities.

Course Prerequisite: MLIS 7300.

### **COURSE ACTIVITIES/ASSIGNMENTS/REQUIREMENTS**

#### **SUBMITTING ASSIGNMENTS**

All projects need to be submitted on time and according to the format designated by the instructor.

**Weekly Class Discussions/Class Exercises** (SLO1, SLO2, SLO3, SLO4, SLO5): 20 points  
Students will participate in weekly discussions and class exercises related to topics for each week.

**Subject Analysis** (SLO1, SLO2): 20 points

Students will analyze the subject about articles and translate the concept terms into controlled vocabulary which represents aboutness about the articles.

**Image Indexing** (SLO1, SLO2): 20 points

Students will analyze subjects of pictures and evaluate their subject analysis by comparing it with the Subject Headings.

**Final project: Organization of Digital Resources** (SLO3, SLO4): 40 points

Students will design and construction of thesauri including domain analysis, vocabulary extraction, concept clustering, ordering, and identifying structural relations in a thesaurus.
