### **NEW POLICIES AND PROCEDURES**

• Remote Proctoring Policy (<a href="https://www.valdosta.edu/academics/academic-affairs/remote-proctoring-policy.php">https://www.valdosta.edu/academics/academic-affairs/remote-proctoring-policy.php</a>) for all faculty using remote proctoring for examinations was approved by the Faculty Senate in February 2024 and the President in March 2024. The policy also contains

- appendices with suggested syllabus statements and other information to assist in implementing the policy.
- Course Repeat Policy for Graduate Students: Under the Graduate Course Repeat Policy, graduate students may repeat a course for grade replacement in a maximum of two courses with posted letter grades of "C," "D," or "F". A course can be repeated for grade replacement only once.

When a graduate course is taken at VSU and repeated at VSU with a higher grade, the highest grade received will be counted in the institutional GPA calculations. If a student repeats a course at VSU but receives a lower grade, the higher grade from a previous attempt will be used in the calculation of the institutional GPA. The courses must be taken and repeated at VSU (http://catalog.valdosta.edu/graduate/academic-standards-regulations/).

### REVISED OR UPDATED POLICIES AND PROCEDURES

- Extended Time for Students to Withdraw From Classes Without Academic Penalty: At its May 2024 meeting, the Board of Regents approved allowing institutions to extend the withdrawal period to the 11<sup>th</sup> week during a 15 week term and, for shorter term classes, generally one to two weeks before the final class day (https://www.usg.edu/academic\_affairs\_handbook/section2/C749/#p253\_withdrawal\_without\_academic\_penalty). VSU has thus extended it withdrawal period beginning this fall semester in order to allow faculty more time to provide feedback to students on their course performance. This fall, for 15 week classes, midterm grades will still be posted by the traditional time (October 9) but the last date for withdrawal will not be until October 31<sup>st</sup>. Similar changes will occur for classes over shorter parts of term. - Revisions to the Faculty Evaluation Model to bring the section on Post-Tenure into alignment
  with USG policy were approved by the Faculty Senate at its January 2024 meeting and approved
  by the President in February 2024. These updates are incorporated in the document at

- Turnitin Draft Coach: Turnitin Draft Coach (available to VSU students through Microsoft Word 365) gives users access to Turnitin Similarity Reports, Citations Reports, and Grammar Guide directly in Microsoft Word on the web. Draft Coach helps students build writing and research skills and provides real-time feedback and guidance on similarity, citations, and grammar. ## **CELT/eLEARNNG**

- A total of 27 VSU faculty have now completed the <u>CELT-eLearning Online Teaching Certificate</u>.
   Since the certificate launched two years ago, a total of 1,140 training hours have also been taken by faculty.
- A cohort of 17 VSU faculty have begun to complete the new <u>CELT-QEP Experiential Learning</u> <u>Certificate</u> that launched late this past spring followed by a retreat in May. Throughout this



coming academic year, they will take additional core and elective courses on topics such as Service-learning, Work-Based Learning, and Experiential Learning for Online classes, and they will be matched with peer mentors who are the QEP's Experiential Learning Faculty Ambassadors to assist with implementing and assessing experiential learning activities in their courses.

- CELT-eLearning will ramp up faculty development on artificial intelligence (AI). CELT Tuesday Teaching Tips and eLearning's Tips and Tolls will focus on AI. A new CELT-eLearning webinar is titled, "Leverage Draft Coach by Turnitin to Improve Student Writing with AI." Or sign up for one or both of the CELT faculty learning communities (FLCs) about AI that will run this fall semester to explore how to integrate AI effectively and ethically into courses. A multidisciplinary team of faculty, led by CELT-eLearning Director Jamie Landau, was also selected to attend the AAC&U's inaugural Institute on AI, Pedagogy, and the Curriculum. They will bring back to VSU what they learn at the institute to educate colleagues about best practices for teaching with AI and academic honesty, address disciplinary differences in approaches to AI, and develop a plan for faculty/staff to leverage AI for "career readiness" of students.
- CELT-eLearning finalized the transition from Collaborate Ultra to Teams.
- eLearning has introduced a series of eLearning Tips and Tools to communicate and promote
  Quality Matters best practices in online course design. Three episodes have been launched, and
  a total of eight episodes are planned.
  - Quality Matters Standards in Action
  - Quality Matters Scaffolding Learning
  - Quality Matters Intentional Engagement
- eLearning partnered with faculty subject matter experts to develop 14 additional online core courses to offer as part of the SmartPath Core program in 2024.
- eLearing collaborated with Student Advising and the Registrar to develop a comprehensive Reference Guide for Advising Online Students.

## IT

#### VSU Wireless

- The entire campus' wireless access points have been upgraded in order to provide more consistent service and to better accommodate students' diverse use (e.g. gaming)
- Main campus Pedestrian Mall, Palms Dining quad and North Campus outdoor gathering spaces are scheduled to have outdoor wireless availability starting the Fall semester
- Working with Athletics leadership to schedule time to install wireless in the Complex to accommodate about 4,500. This should be later in the 24-25 academic year.
- Working with external vendors to bring wireless access to the VSU front lawn (later in the academic year into next summer)
- Continued conversion of VSU lab spaces to utilizing Virtual Desktop (VDI) technology allowing students to access core lab platforms in a VDI-ready campus lab or remotely from their personal device.
- Continued upgrade of Windows 10 faculty, staff, and lab machines to Windows 11 machines (end of support for Windows is 10/14/2025)
- Initiated an Artificial Intelligence committee that is engaging with multiple technologies under the AI umbrella (chatbot, generative AI, reporting and dashboard presentation of data)
- Will start the process of building a student experiential learning IT lab in Pine Hall for students to engage with different aspects of IT support and configuration more to come.

## **OCCA (Online College for Career Advancement)**

- Fall 24 semester is the first semester in which target OCCA courses are going through Quality Matters review and certification
- OCCA Program specific marketing will be active in the Fall semester with a geographic focus in Georgia and surrounding regional states.
- OCCA will fund its Academic Affairs initiatives at just under \$2.1M for the academic year. This is up about 40% from the prior academic year.
- Target enrollment of about 1,320 students in the Fall 24 semester (about a 45% YoY increase)

#### **ENROLLMENT AND STUDENT AFFAIRS**

- CIVITAS platform will be replaced with the SLATE Student Success platform. A soft launch with Advising will roll out at the start of Fall semester. Additional guidance on reporting and documenting student concerns and performance alerts will also be included. Look for training opportunities to come in August – September.
- Hardship and Medical Withdrawal deadline for students is the last day of class. After the last day of class, any withdrawal submitted will require a letter of support from a professor or department head.
- Absentee Notifications submitted to the Vice President's office are reviewed and all attempts
  are made to verify the legitimacy of the absence. When notices are sent to faculty it is for
  information purposes of a verified absence. Approval of absences within the guidelines of the
  course syllabus still remain responsibility of the professor. It is encouraged to work with
  students as much as possible to make up missed work or exams when absent.
