Course Description

Capstone is required for partial fulfillment of the requirements for the MLIS degree. Emphasis will be on synthesis of knowledge, honing writing and presentation skills, and creating a professional development plan.

Course Objectives

At the conclusion of the course, the student will be able to:

1. Synthesize knowledge gained throughout the course of study and apply that knowledge to the consideration of current professional issues.
2. Make an effective professional presentation.
3. Write a paper of publishable quality.
4. Create a professional development plan.
5. Navigate the job hunting process.
6. Articulate personal professional goals.

Course Prerequisite or Corequisite: Taken during the final semester of study

Required Text

Rubin, Richard E. *Foundations of Library and Information Science*. New York: Neal Schuman. The edition you used in *Foundations* will be fine.

Assignments

Major presentation and paper: You will prepare a conference-style presentation and a paper of publishable quality on a topic of your choice, with the topic subject to instructor approval. Presentations will last 15-20 minutes, with 10 minutes for questions and discussion. Paper length and style will depend on topic and on requirements of appropriate publication venues. Paper topic selection is due February 1. Draft due April 26. Optional rehearsal or “dry run” of presentation can be scheduled on May 2 or 3 in Macon, or using LiveClassroom on May 4, 5, or 6. Presentation and final paper are due at class on May 7 or 8.

Portfolio: You will update, present and discuss your portfolio. Bring your portfolio to class in Atlanta on January 17, 2009. Feedback will be provided by the instructor and classmates. Discussion and sharing of portfolio issues should occur via WebCT Vista. Revised portfolios are due on May 7 or 8, 2009. After grading and review by other faculty members, your portfolio will be returned by mail or package service.

Professional Development Plan: Each student will create and record a personal plan for professional development. For students who need to seek employment, this will include a detailed job-hunting plan. For all students, this will include plans for solidifying and updating their professional knowledge in the two-year period following graduation. Submit via WebCT Vista no later than March 1, 2009.

Reflection on MLIS Experience: Each student will prepare an essay that reflects on and evaluates his or her experience with the MLIS degree program. The essay will include the student's determination of strengths and weaknesses within the program. Submit via WebCT Vista no later than March 29, 2009.

Current Issues Discussions: There will be six current issues discussions lasting one week. You or your team will moderate a class discussion a current issue in LIS. You will use a topic that has appeared in LIS or popular literature during the past year. Current issue topics will be discussed at the Atlanta Class. Topics are due for approval on January 23, 2009. The first topic will be selected at the first class. For each topic, you will identify pieces of published literature that state all sides of the issue and you will prepare one or more questions to guide the discussion. Each team will summarize its discussion in WebCT Vista no later than March 8, 2009.
